

ORDINANCE 2015-13

AN ORDINANCE OF THE CITY OF MARY ESTHER, FLORIDA, PROVIDING FOR AMENDMENT OF THE CODE OF ORDINANCES CHAPTER 15; PROVIDING FOR A NEW SECTION 15-42 MISTY WATER BOAT LAUNCH; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City is committed to a fair and uniform application of its codes and ordinances.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MARY ESTHER, FLORIDA THAT:

SECTION I - AMENDING

SECTION 15-42 MISTY WATER BOAT LAUNCH

(a) Use of boat launch.

(1) All persons using the Misty Water Boat Launch shall pay the required launch and recovery fee as adopted by the City Council and obtain a launch and recovery permit. Failure to pay the required fee may cause the immediate issuance of a citation.

(2) The launch and recovery permit shall be exclusively for launching and recovering marine vessels. Issuance of the permit and payment of the fee does not guarantee the availability of parking.

(3) All persons who use the Misty Water Boat Launch shall either obtain an annual launch and recovery decal from City Hall or obtain a daily launch and recovery permit located at the Misty Water Boat Launch. An annual decal shall be properly affixed the left side of the trailer tongue of the trailer transporting the vessel and be readily visible for inspection. A daily permit shall be placed on the driver side dash inside of the vehicle transporting the vessel and be readily visible for inspection. If the permit or decal is not readily visible for inspection or if the permit is not fully completed and accurate, it shall invalidate the permit or decal and a citation may immediately be issued.

(b) Use of permit to deceive.

(1) Any person found to have obtained a launch and recovery permit or decal illegally or deceitfully shall be subject to a fine equal to a third offense.

SECTION II - SEVERABILITY

Should any part of this ordinance be declared unconstitutional or void by a court of competent jurisdiction, the remaining parts shall remain in full force and effect.

SECTION III - CONFLICT


This Ordinance shall prevail over all prior Ordinances or Resolutions or parts thereof in conflict herewith.

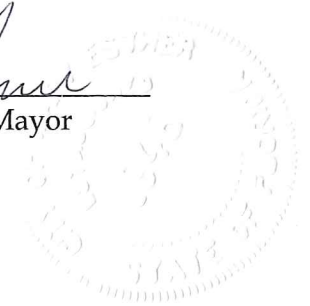
SECTION IV - EFFECTIVE DATE
